The present conditions of sale aim to define the contractual relations between MAGNET SURF SCHOOL and the buyer, and the conditions applicable to any purchase made through service providers and / or intermediary partners, whether the buyer is professional or consumer. These booking and cancellation conditions will prevail over any other general or specific conditions not expressly approved by MAGNET SURF SCHOOL. MAGNET SURF SCHOOL reserves the right to modify its conditions of sale at any time. In this case, the applicable conditions will be those in force on the date of purchase by the buyer.

1. The rates

Surf lessons and courses are sold at the price indicated on the site and MAGNET SURF SCHOOL brochure. The prices are indicated in euros inclusive of tax and can be changed at any time by the management of the establishment on the various communication media of MAGNET SURF SCHOOL. In this case, the applicable prices will be those defined between the management and the client on the date of the reservation.

2. Reservations

Customers who wish to subscribe to a registration must complete and sign the registration form on which it will indicate all the contact details requested. He must also make the payment under the conditions provided and confirm his registration. The confirmation of the reservation entails acceptance of these conditions of sale, the acknowledgment of having perfect knowledge of them and the waiver of availing oneself of its own purchasing conditions or other conditions. For minors, parental authorization must be completed on site. Surfers must not suffer from any contraindication to the practice of surfing and report during registration any health problem, even mild.

3. Payment terms

When registering for a surf course and / or course at the MAGNET SURF SCHOOL surf school, the buyer must send a deposit check or a bank transfer, to confirm registration, if it is made more than 7 days before the start of the course. The client must pay the full amount of the reservation on site on the first day of the course / course, if registration is made less than 7 days before the start of the course.

4. Cancellation and refund

Cancellation by MAGNET SURF SCHOOL: In case of bad weather conditions (thunderstorm, too strong sea, pollution), surf lessons cannot be provided by MAGNET SURF SCHOOL surf instructors. In this case, we offer customers to postpone the course as much as possible or it will also be offered. In the event that no solution is found, a refund may be considered. If the trainee cancels their registration, we will reimburse the lessons only if they are canceled 48 hours in advance or on presentation of a medical certificate stipulating the contraindication to the practice of surfing by the trainee concerned.

6. Responsibilities of the buyer

Anyone participating in a surf lesson is taken care of and under the responsibility of MAGNET SURF SCHOOL by calling his name until the end of the lesson. Parents or legal guardians of minors must ensure the progress of the service. MAGNET SURF SCHOOL is in no way responsible for students outside of class. Course participants are required to follow the safety instructions, otherwise they will be excluded from the session.

7. Responsibility of MAGNET SURF SCHOOL

MAGNET SURF SCHOOL cannot be held responsible for any moral or bodily harm caused by third parties to course participants. MAGNET provides legal liability coverage in accordance with the law. If the customer wishes additional guarantees, it is up to him to subscribe them personally. MAGNET cannot be held responsible for thefts committed on the beach or in the vehicle. It is advisable not to come to class with valuables.

8. Image rights

In the event of image capture (photos or videos), the participant must notify MAGNET SURF SCHOOL of the refusal that his image be reused and / or disseminated via the communication media of MAGNET SURF SCHOOL, to the supervisor or to the manager of the activity.

9. Personal data
