#### 1. The rates

Surf lessons and courses are sold at the price indicated on the MAGNET SURF SCHOOL website, brochure and brochure. Prices are indicated in euros including tax on the various MAGNET SURF SCHOOL communication media and can be changed at any time by the management of the establishment. In this case, the applicable rates will be those defined between the management and the customer on the date of the reservation.

#### 2. Reservations

Customers who wish to register must complete and sign the registration form on which they will indicate all the requested contact details. He must also make payment under the conditions provided and confirm his registration. Confirmation of the reservation entails acceptance of these conditions of sale, recognition of having perfect knowledge of them and the waiver of taking advantage of one's own conditions of purchase or other conditions. ### 3. Payment terms

## 4. Cancellation and refund
